Competition rules:

- I. The fencing competition shall be conducted in accordance with standard rules of FIE. The Directoire de' Technique shall deal with any unforeseen incidents that are not covered by the rules.
- II. Piala Warisan will be given to the **most collective** Gold Medals of the State Associations, if the calculations of gold medals are a tied, the most medals of silver and following to bronze will be calculated. Rare cases of medals tied for example total of gold, silver and bronze for both State Associations are the same, a 15 points selective weapon category challenge will be held.
- III. The event pool and rounds will be adjusted based by number of participants. If less than 5 players, **MAFA have the rights to cancel the event** and refund will be given out to the respective State Associations.
- IV. **P card** will be practice in the event for Epee category. If P black card are given, the fencer's rank is based on pool seeding results based by the DT handout data.
- V. MAFA will provide referees in each category; volunteers referee is welcome and must register early before 22nd October 2024 to avoid miscommunications and full quota. However, if there is not enough referee to cover the event, **MAFA have the rights to appoint a referee** from the state that have the **most fencers**.
- VI. All referees will be given task by the **Directoire de' Technique** and MAFA will give out allowance per day of **RM200 to the referees**.
- VII. Fail to conduct a proper referee task will be given a penalty of RM 300.
- VIII. Any protest against decisions of a referee must be made immediately before any decision is made regarding the subsequent hit or **appeal to the DT** in charge for further actions.
- IX. Jury of appeal shall be under the chairmanship of the MAFA President and DT in charge. The decision of the Jury of Appeal is final.
- X. Maximum of two (2) entries are allowed per fencer.

Equipment:

1. A weapon size 5 will be used by fencers, FIE equipment's are not compulsory, however rusty weapons, torn fencing attire and short socks are not allowed. Fencer's clothing must be made of sufficiently, robust material and should be in good condition.
2. A weapon test area will be provided at level 1 venue. Weapon check will be done on the piste before each bout. Fencers are allowed to borrow from other fencers for Sabre and Foil Lame.
3. Failed to do so will jeopardise the event schedule and the Directoire de' Technique are given power to terminate the fencer's entry based on the information given by the referees. No refund will be given.

- 5) Entry Certificates



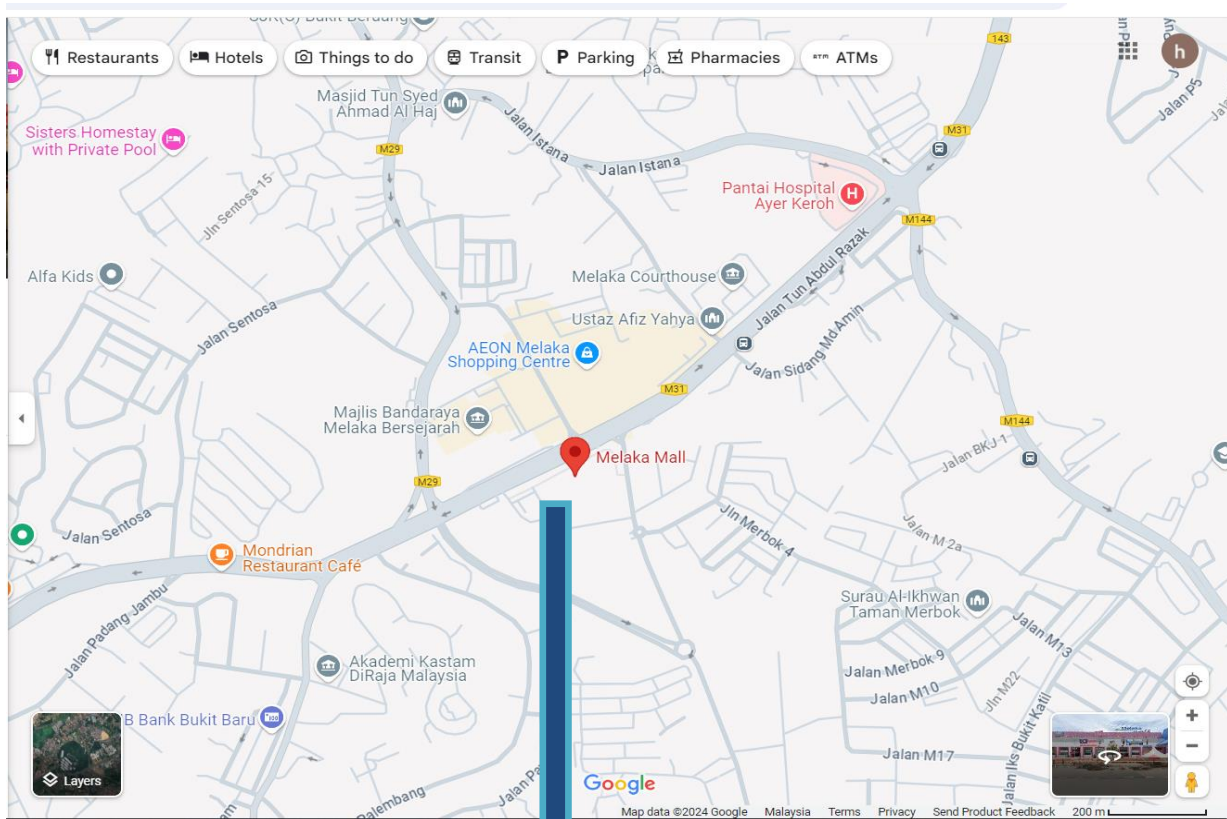

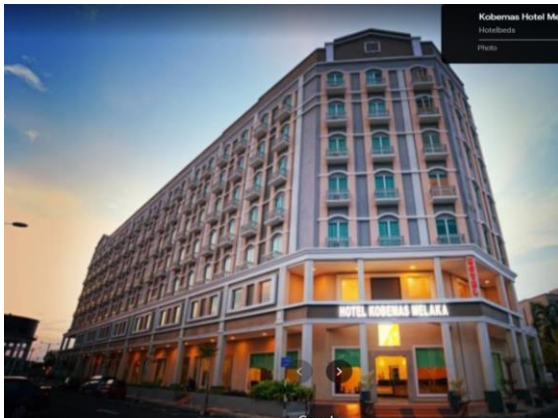
