#### 4. Participation:

- Each invited country can field as many entries they want for the individuals.
- Age eligibility:  
**Under 14 of age and Open (no age limit)**
- For Team Event (Open Category):  
each country shall comprise **three (3) competitors and one (1) reserve fencer**, a maximum of **three (3) teams** for each team event.

#### 5. Entries:

- Preliminary entry (by numbers) - **FORM 1**.
- This form must be received by the organizing committee not later than **10<sup>th</sup> July 2025**.
- Final entry (by name) -**FORM 2A, 2B**. These forms must be received by the organizing committee no later than **18<sup>th</sup> July 2024**.

#### 6. Competition Rules

- The fencing competition shall be conducted in accordance with the current statutes and rules of FIE. In case of disagreements in interpretation of the rules, the latest FIE rules in the English version shall prevail. The Directoire de' Technique shall deal with any unforeseen incidents not covered by the rules.

#### 7. Equipment

FIE equipment is not compulsory, however please be mindful that we MUST follow the listed guidelines below: *(Weapon check will be on the piste by referees)*

- Rusty Weapons are not allowed
- Torn Fencing Attire is not allowed.
- Black socks and short socks are not allowed
- **Inner plastron** is compulsory for all fencers/all weapons
- **Chest protector** (Compulsory for women)
- For SABER, only gloves with lame will be allowed, overlays are not accepted
- Mask wire and Body wire must be in good condition.
- Conductive bib for foil is a must
- Required for jacket and breeches (350N or higher)
- FOIL/SABRE Mask are not allowed for EPEE Event

## 8. Competition Management

### **a. Referee**

Participating delegations must be accompanied by number of referees according to the FIE Rules as follows:

1 – 4 fencers	: 0 referees
5 – 9 fencers	: 1 referee
10 or more fencers	: 2 referees

**Note :** Please ensure that the referees are to be properly attired. Please bring a **black jacket / blazer and long pants**.

***\*\*If the participating delegation fails to provide the required number of referees, a penalty fee of RM 300 / day/ referee will be imposed. The fee should be paid before the start of the competition. \*\****

### **b. Directoire de Technique (DT)**

The DT will be responsible for the technical organization of the competition.

### **c. Jury of appeal**

The jury of appeal will consist of one representative for each participating country / state under the chairmanship of the Organizing Chairman, or a representative appointed by him/her. The decision of the jury of appeal shall be final.

### **d. Protests**

Appeals against decisions of the referee should be immediately made by the competitors to the referee, before any decisions are made regarding the subsequent hit. If the referee could not maintain his decision, the complaint will be brought to the attention of the D.T. Every appeal to the jury of hit appeal must be accompanied by a deposit of RM 500.00 which will not be refundable. This sum will be confiscated in the whole or in part if the appeal is rejected by jury of appeal. Appeals must be lodged and written in Bahasa Malaysia and / or English.

## 9. Prize

A medal will be awarded to the 1st, 2nd, and joint 3rd places and certificates for winners in each event.

Prize giving ceremony will be held daily at the end of day for each event.

## 10. Entry fees

Individual event - RM 180 per fencer / per event

Team event -RM 500 per team / per event

Entry fees must be paid **before** the event start.

The organizers will only accept the local currency if paid by cash.
